

Load Battery into Cap


Ensure that battery, o-ring and cap lid are functional and secure!

These pieces are critical to giving you a water and dust tight seal and must be firmly in place!

Positive side faces into the cap. Attach the cap to your PRECISION pod.


Reinstall

PRECISION by rotating the crank a few times




Pair PRECISION

with power-capable devices




Ride

Zero


PRECISION using paired device.
